Regular Members are business firms or entities which are producers, brokers, distributors, exporters, importers, and suppliers of natural sausage casings throughout the world, who have qualified in accordance with the requirements, set forth in the INSCA bylaws and have been admitted to membership and have paid all requisite fees established for such class. Regular members shall have full voting privileges as set forth in the bylaws.

**ASSOCIATION MEMBERS: 1,125.00 (USD) + 50 \$ Merchant fees**

Association Members are natural casing associations located anywhere in the world.

**AFFILIATE MEMBERS: 1,125.00 (USD) + 50 \$ Merchant fees**

Affiliate Members are business entities of which a majority ownership lies with a current INSCA Regular Member firm (hereafter referred to as the "Parent Company"). Affiliate Members are producers, brokers, distributors, exporters, importers, and suppliers of natural sausage casings throughout the world, who have qualified in accordance with the requirements of INSCA. Affiliate applications must provide documents verifying majority ownership by the Parent company. Such documents can be sent directly to the INSCA Legal Counsel.

**ASSOCIATE MEMBERS: 1,125.00 (USD) + 50 \$ Merchant fees**

Associate members are trade associations, chambers of commerce, or business firms supplying materials or services to the industry, or producing products derived from by-products of natural casing production.

- \* After having qualified in accordance with the requirements set forth in the INSCA bylaws and having been admitted to membership and having paid all requisite fees established for such class, all Affiliate, Associate and Association Members shall be treated equally with the Regular Members and afforded all other privileges set forth in the bylaws except that Affiliate, Associate and Association Members shall have no voting privileges.
- \* INSCA Memberships are presented for approval by the Board of Directors. Application processing generally takes 2 to 4 weeks. You will be notified in writing of your acceptance or denial as a member of INSCA.

**Making Payments to INSCA**
